

A Petition from the Free World to the Honorable President Biden

August 15, 2023

Honorable President Biden:

PETITION

We citizens of the world beseech you to heed our plea.

We plead for your further leadership and aid to the people of Ukraine, so that they may defeat the genocidal barbaric and imperialistic Russian invasion of their country. We remind you of the horror promulgated by Russia on Ukrainian children.



As the president of the United States, you have extraordinary authority and responsibility to lead like-minded nations valuing the rule of law, fundamental human rights, and democracy, which we refer to as the world order.

That world order is inconsistent with Russian victory in Ukraine, and it is only consistent with a decisive Ukrainian victory and Russian defeat in Ukraine. Lacking a decisive Ukrainian victory and Russian defeat in Ukraine, the world order will, in effect, no longer exist, ushering in a new age of imperialism by conquest and barbarism. Accordingly, the only resolution consistent with our values for rule of law, fundamental human rights, and democracy, and that will preserve the world order, is a decisive Ukrainian victory and Russian defeat in Ukraine.

Only a decisive Ukrainian victory and Russian defeat in Ukraine can avoid a frozen conflict, can deter future Russian invasions, and can show world resolve to protect the values which we all cherish.

And we submit that this outcome, and hence the fate of future generations, is largely in your hands.

WE BESEECH YOU TO ANNOUNCE WHY THE UNITED STATES SUPPORTS UKRAINE DECISIVELY DEFEATING RUSSIA

Your policy regarding Ukraine has only gone so far as to state that Ukraine must decide what is an acceptable resolution. You have not stated that your policy is to support the rule of law, fundamental human rights, and democracy, and that the only outcome consistent with that policy is a decisive Ukrainian victory and Russian defeat in Ukraine. In other words, you have not clearly explained moral and political basis for supporting a decisive Ukrainian victory.

We beseech you to state that your policy is to support the rule of law, fundamental human rights, and democracy, and that the only outcome consistent with that policy is a decisive Ukrainian victory and Russian defeat in Ukraine.

Some people assert that the US entered into an informal agreement with Russia, limiting the quantity and quality of security assistance the US will provide to Ukraine.

We beseech you to disavow any such agreement, so that the world knows that you stand with Ukraine in defense of our shared values.

WE BESEECH YOU TO TAKE THE ACTIONS TO HELP UKRAINE DECISIVELY DEFEAT RUSSIA

The free world appreciates all that the US has done, to date, for Ukraine. Including organizing Rammstein, assembling the coalition of like-minded nations, and providing humanitarian and security aid. However, everyone recognizes that aid to Ukraine has been too slow to *decisively* turn the tide of the war, allowing Ukraine to take back all of its sovereign territory.

We beseech you to do what you can to change that. We beseech you to go “all-in” for Ukrainian victory.

WE BESEECH YOU TO EXPEDITE WHAT EXPERTS SAY UKRAINE NEEDS TO WIN DECISIVELY

By all reports from military experts, intellectuals, journalists, and the Ukrainian military, decisive Ukrainian victory requires long-range missile systems and multi role fighter jets. You have authority granted overwhelmingly by Congress, under the Ukraine Democracy Defense Lend-Lease Act of 2022, to expedite those things by drawing them from existing US military stocks.

We therefore beseech you to expedite the provision to Ukraine and training of Ukrainian personnel on long-range missile systems and multi role fighter jets.

WE BESEECH YOU TO MEET YOUR PROMISE TO FULLY SUPPORT UKRAINE

Your fiery speeches in Warsaw and Kyiv conveyed a great promise that the US would fully support Ukraine against the barbaric Russian invasion, and gave us hope that the nightmare that is Russia’s invasion, would be defeated. Yet many people are dismayed by the US’s failure to promptly provide promised Abrams tanks, by delays in authorizing F-16s, and by further delays in providing F-16 training for fighter pilots.

We beseech you to meet your promise by fast-tracking the security aid Ukraine needs to win decisively.

WE BESEECH YOU TO ENFORCE AND STRENGTHEN SANCTIONS INHIBITING RUSSIA’S MILITARY PRODUCTION

We are also alarmed by increased Russian accelerated production of cruise missiles and other weapons systems, despite sanctions intending to inhibit their production.

We beseech you to enforce existing sanctions, close loopholes in existing sanctions, and impose whatever additional sanctions that may be imposed that can inhibit Russian production of

military equipment.
