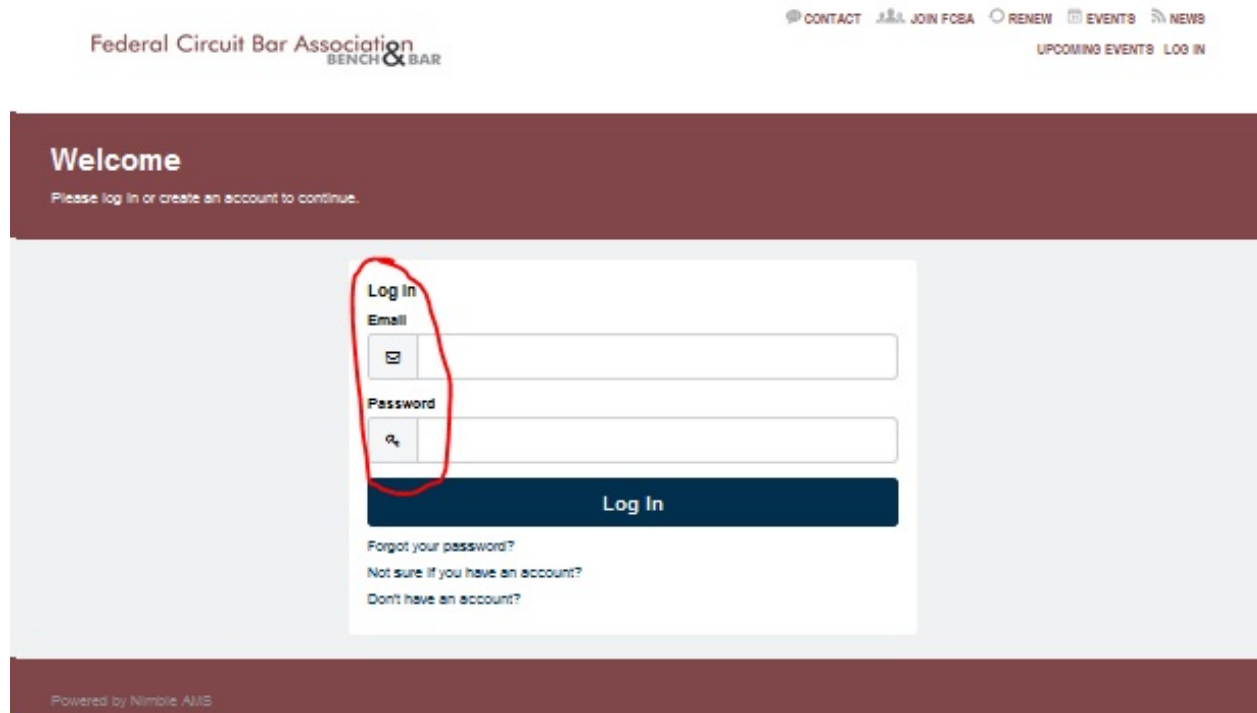
Joining an FCBA Committee

Please note that this is not an official FCBA document. I provide this document to facilitate FCBA members joining the PTAB and TTAB committee which I currently co-chair. However, this instruction is generic to joining any FCBA committee. A precondition to joining an FCBA committee is being an FCBA member and having an FCBA username and password.

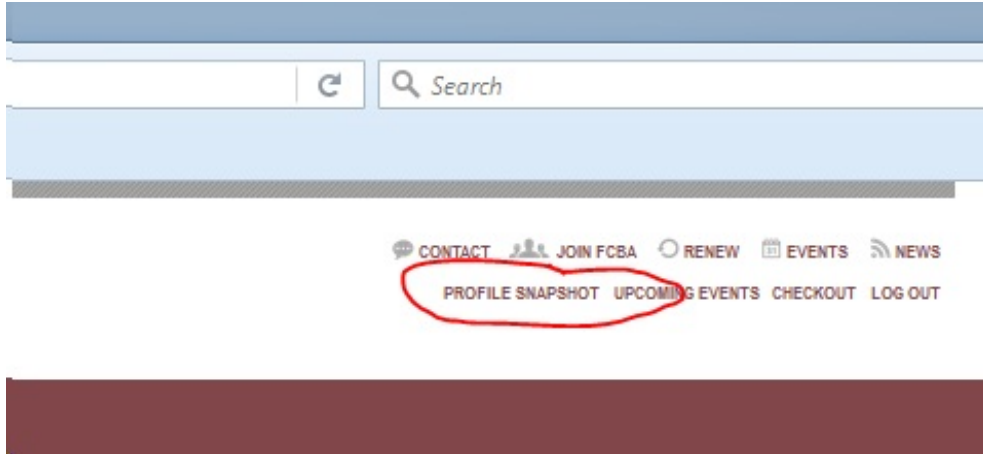
To join an FCBA committee, such as the PTAB and TTAB committee, take the five actions shown below.

First, log in to your FCBA account at URL: [https://myfcba.fedcirbar.org/NC Login](https://myfcba.fedcirbar.org/NC>Login)

Then, click "Join" across from the Committee you want to join, as shown below.

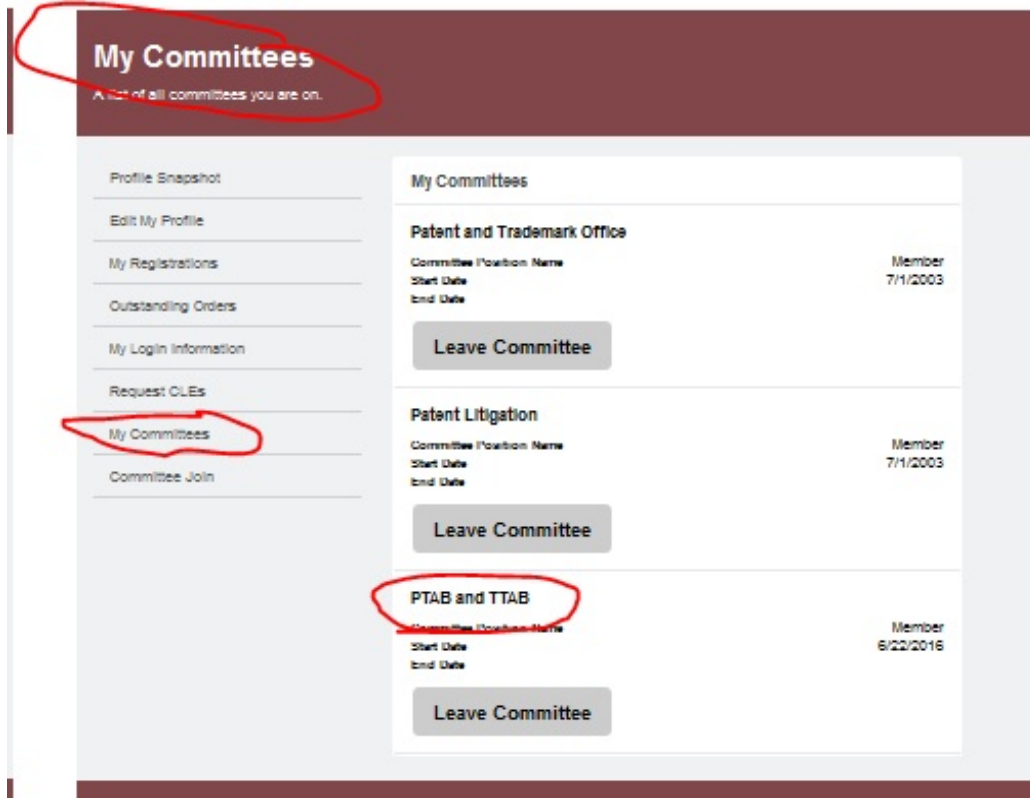
